



Homelessness Programs: Data Collection Tool (DCT) - Version 2.1 Monthly Reporting Tool (2013)

This version of the DCT (V2.1) was designed with several data selection and data entry features not available in past versions. Before you begin entering data, please review all the information on this page to familiarize yourself with the features and options.

To adjust the viewable area of the worksheet use the "zoom" function located in the "view" menu tab along the top - using a zoom range of 80%-100% will work best.

Data fields (data entry spaces) have been highlighted in yellow for quick and easy identification. A space in which you can enter data (numbers and/or text) will be this colour: 

Data selection boxes have been added to help you pick items from lists and to identify relevant information. To check a box click on it with your mouse pointer.

A checked data selection box will look like this:

An unchecked data selection box will look like this:

Many of the worksheets require information for specific population target groups representing different household types. For example, single individuals, couples with children, couples with no children, etc. The different target groups have been divided into separate sections. Each of the sections has been labelled. Sections can be expanded and collapsed as required.

Use the expand/collapse feature located on the left margin. Look for the [+] symbol to expand the section.

When a section is expanded the [+] symbol will automatically change to a [-] symbol allowing you to collapse the section when completed.

Expanding a section automatically relocates your view to the bottom of the section (this relocation is a default setting). Scroll to the top of the section to ensure all required data is provided.

Sections that can be expanded or collapsed will look like this:  Click the symbol to the left to expand (+) and collapse (-) this section

For instructions about how to fill in data fields or for more details about what information is required use the red triangle (comment indicator) in the upper left corner of a cell that looks like this: If you hold your mouse pointer over the red triangle a pop-up comment will appear with information.

Instructions on how to fill out the section will appear in a speech bubble that looks like this: 

Important information will appear in a starburst that looks like this: 

General information will appear in a standard comment box that looks like this: 

Some of the tables in the worksheets contain drop-down lists. The drop-down list can be accessed by clicking the cell and using the drop-down arrow. A drop-down arrow looks like this:





Better Coordination/Improvement of Service Delivery	This outcome refers to community planning and priority setting, data development and coordination, and partnership development to coordinate and improve service delivery within communities.
Capital Investment	This activity area includes the pre-development, purchase, construction, renovation of property and the purchase of appliances and furniture for any emergency, transitional, supportive and non-residential facilities
Client Supports	Services directed towards assisting individuals and families to secure benefits as well as supports with daily living (e.g. referrals, individual case management, personal identification, transportation, legal/financial assistance, and child care).
Couple No Children Household	A household that comprises of two people living together who identify as a couple and do not have any children they support. (Please note the definition/explanation for "Household status when children not in the care of their parents")
Couple With Children Household	A household that comprises of two people living together who identify as a couple and have children they support. (Please note the definition/explanation for "Household status when children not in the care of their parents")
Emergency Shelter Facilities	Facilities providing temporary and short-term accommodation (for a period of up to six months) to individuals and families who are experiencing homelessness. These facilities provide single, shared bedrooms or dormitory-type sleeping arrangements which can include seasonal beds or mats. Emergency shelters may also include motels/hotels and other types of temporary sheltering facilities.
Employment Development Services	Services that help to develop or enhance employability skills such as: training, educational upgrading or job search assistance.
Enhanced Understanding of Homelessness	Knowledge development and dissemination of information that increases the understanding of the causes of homelessness, factors impacting housing stability, services required and available to address homelessness and innovative approaches and best practices to address the unique needs of homeless people and those at risk of homelessness
Health or Treatment Related Supports	Services that directly provide or are related to health and treatment supports, (i.e. any form of medical professional care, addiction treatment programs, psychological counselling, and specialization in dealing with sexually-transmitted infections)
Hidden Homeless	Hidden homelessness refers to individuals or families living in locations not meant for human habitation or who are continuously moving among temporary housing arrangements provided by strangers, friends, or family (i.e. "couch surfing").
Homeless	The condition of being without accommodation. This includes living on the street, in an emergency shelter, couch surfing or living in a space not intended for habitation (i.e. abandoned buildings)

Term	Definition/Explanation
Homelessness Prevention or Housing Loss Prevention	Activities that help prevent those who are at imminent or immediate risk of losing their housing from becoming homeless and landlord/tenant mediation. This also includes helping people move to more appropriate housing in order to maintain housing stability. This should only include the outcomes that are anticipated to be achieved as a result of HPS funding. Clients receiving housing loss prevention interventions must be followed-up after three months to ensure that they have maintained their housing
Homelessness Reduction or Housing Placement	A service provided to a homeless client that leads to a transition from homelessness to transitional, supportive or regular/permanent housing.
Housed	Having accommodation, either temporary/transitional or permanent, that provides someone with their own space and an address. Someone living in an emergency shelter is <u>not</u> housed, they would be considered homeless (please read the definition/explanation for "homeless" to ensure you are recording information correctly)
Household	A single individual or a group of individuals who live together. Groups may be lone parent families, couples, two-parent families, and other combinations of individuals that have identified themselves as living as a household in the past or would want to do so in the future. Please note the definition/explanation for "Household status when children not in the care of their parents".
Household Status When Children are Not In The Care Of Their Parents	Children in <u>permanent</u> care of CAS/CCAS are not considered to be part of the household. Children in <u>temporary</u> care of the CAS/CCAS should be included in the household because it is recognized that finding and maintaining stable housing is necessary for the parent(s) to retain custody and plan for their child(ren)'s return.
Households served	Administrative data element of households receiving assistance to achieve a housing result.
Housing Outcome	A change in housing status that involves someone living homeless or being discharged from institutional care, moving into temporary or permanent housing. It could also involve someone who was housed moving into a more stable housing situation. A housing outcome could also include someone moving into homelessness or into a more unstable housing situation.
Housing Support	Housing support includes: Assistance in finding permanent housing, assistance in finding temporary accommodation, moving assistance, assistance maintaining temporary or permanent housing.
Increase Quality of Facility	Capital investment activities that improve the quality of the facility, increase efficiency through the purchase of new computers, improve sanitation of a new waste disposal system, or provide minor renovations such as painting
Increase Safety and Compliance with Building Codes	Capital investment activities that increase building safety such as: installing a security system, changes to electrical system, insulation of building etc.
Increase Sustainability of the Facility	Capital investment activities that increase the sustainability of the facility can include paying down mortgages to reduce operational cost or installation of new windows which results in lower heating costs allowing for more money to be spent directly on client services. For annual reporting you will be asked to describe your activity in more detail.
Institutional Discharge	The process of a person being discharged from the criminal justice system, a health facility or the child welfare system.
Investments Strategic and Aligned	This outcome refers to investing funds to target the greatest needs and affected client groups while ensuring that those investments complement those of other stakeholders and partners and do not create overlap and duplication or run counter to other partners' efforts.
Labour Market Integration Services	Services that help to develop or enhance employability skills such as: training, educational upgrading or job search assistance.

Term	Definition/Explanation
Life Skills Training Services	Training related to the development of effective life skills promoting greater self-sufficiency and/or improved coping abilities. Life skills training includes sessions on healthy relationships, effective communications, parenting skills and/or anger management skills. Life skills support assistance with nutrition, clothing, personal hygiene, budgeting, bill paying, shopping, and household cleaning/maintenance.
Lone Parent Household	A household that has one parent living with and providing for one or more children. Please note the definition/explanation for "Household status when children not in the care of their parents".
New Client	Someone who is new to your services and has either never accessed your services before or has not accessed them in at least one year.
Newcomer to Canada (arrived in last 5 years)	Individuals who come to Canada to live within the last 5 years and were not born in Canada. This includes refugees and immigrants.
Non-Residential Facilities	Facilities that provide services to meet basic needs and/or provide services to promote longer-term stability of individuals and families who are homeless or at risk of homelessness. Examples include: food banks, soup kitchens, drop-in centres multi-service centres, clothes/furniture bank , counselling centres and can include the purchase of a van/vehicle.
Partners Engaged	This outcome refers to the engagement of various partners in the development of a continuum of services for the homeless and at-risk populations. It is a result of strategic partnership development as well as knowledge development and dissemination. Partners can include: key stakeholders within communities, municipalities, federal departments and agencies, and research bodies.
Participatory Service Planning	This refers to the process of planning for a service or a system of services in a way that includes people who are providing those services as well as people who are accessing those services in the planning process. This must go beyond simple consultation to include stakeholders participation and input in the planning process in an ongoing way from beginning to end.
Person with a Disability	As defined by the Ontarians with Disabilities Act (2001), any degree of physical disability, cognitive or developmental disability, learning disability and/or mental health issue. Alcoholism and drug addiction are also identified as disabilities under the Ontario Human Rights Code.
Personal Support Services	Services that contribute to the capacity of households e.g. emergency supplies, trusteeship, advocacy, information about mainstream services, transportation to mainstream services.
Quality of Life related supports	This refers education/training, life skills, employment, recreation related support services.
Racialized	A racialized person is someone who may experience racism because of the colour of their skin. Racialized is preferred over 'visible minority' or 'person of colour' to emphasize the historical legacy of racism that separates people based on the colour of their skin, rather than because of actual biological differences.
Regular/Permanent Housing	Refers to housing that is not supportive housing and that can be long-term. Includes a house, apartment or room (including social housing) that a family or individual rents or owns and from which they may come and go as they wish. Regular/permanent housing may include living arrangements with friends or family members that are expected to be long-term. Residents in regular/permanent housing can be receiving supports from case managers, outreach workers or other services.
Single Person Household	A one person household where that one person lives on their own not having a partner/spouse or child living with them. Please note the definition/explanation for "Household status when children not in the care of their parents".

Term	Definition/Explanation
Social & Economic Outcomes	Economic and Social Outcomes: Economic integration focuses on interventions that directly support individuals who are homeless or at risk of homelessness experience changes in their economic or financial circumstance. For example: moving from no employment to full-time employment, or moving from social assistance to employment income. Social integration focuses on interventions that directly support individuals who are homeless or at risk of homelessness to experience changes in their social circumstance. These include improvements in the areas of volunteer work, education, social and cultural involvement and personal development. For example: starting a full or part-time education program or development of social and cultural networks.
Street	A place that is not intended to be used as a temporary or permanent residence, e.g. public space, barn/garage, car, tent, etc. (does not include couch surfing).
Supportive/Supported Housing	Housing for individuals and families that include supports and services integrated into the housing with no maximum length-of-stay duration. Services depend on clients' needs and are provided to help residents maintain independence and stability to promote social inclusion
System and Community Development	This refers to activities and outcomes designed to make improvements to the housing and homelessness service system as well as the community at large. They may aim to improve your community's capacity to prevent and reduce homelessness. Examples include: information sharing and coordination of service provision, data collection management and data sharing, training of front-line workers of service organizations that work directly with the homeless and at-risk population, community forums and events, participation in local committees on homelessness and the community planning process, local research, information collection and sharing, partnership and network development, co-ordination of service provision, collaboration between groups, organizations, sectors, governments, stakeholders to develop.
Temporary/Transitional Housing	Housing facilities that provide services beyond basic needs and that, while not permanent, generally allow for a longer length of stay than emergency shelter facilities (up to three years). These facilities offer more privacy to residents than emergency shelters, and place greater emphasis on achieving self-sufficiency and full participation in society.
Transgender	Transgender should be self identified by the person accessing services and not be assumed by the staff person collecting the information. A person who identifies as transgender may be someone who was born with the physical characteristics of one gender but psychologically and emotionally feels more aligned with the opposite gender. A person may have gone through a transformation of some sort to align their physical sex characteristics with their psychological ones. Some transgender people would not identify themselves as being "transgender" but rather identify as a either woman or man. Do not assume a person who appears, to you, to be transgender wishes to be referred to as transgender. Follow the lead of the person and mark them as the gender they prefer to be identified as.
Unsafe/Unsuitable Housing	A housing situation that has been identified as unsafe or unsuitable for the individual/household your project is serving. Examples that might apply here are: a person who is living with someone that abuses them, a large family that is overcrowded in their small housing unit, a person who may have a disability but the housing unit they live in is not modified appropriately to meet their needs, a person who is a recovering addict and trying to abstain from substances but living in an environment with high drug and/or alcohol use around them.
