# Community Readiness Assessment Worksheet

## *Understanding of HF4Y*

Assessing whether there is a common understanding of the Housing First for Youth program model and philosophy is important because many organizations and communities make claims to be “already providing Housing First for Youth,” while their approach is inconsistent with the core principles of the program model. If there is little understanding of HF4Y in your community, community partners will need to receive training and agree to the core principles before planning can proceed. Without this initial buy-in, it will be very difficult to carry out the change management required.

To what degree does the frontline/program staff at my organization understand HF4Y and how it's different from Housing First (for adults)?			
To what degree do other youth-serving agencies understand HF4Y and how it's different from Housing First (for adults)?			

*Alignment with HF4Y*

There may be instances where local policies and procedures are at odds with HF4Y policies. In these cases, steps will need to be taken to reconcile these contradictions and ensure that local service organizations comply with program fidelity.

Does your organization practice zero discharge into homelessness?

*Capacity for HF4Y*

The next assessment area includes determining an organization’s ability and resources to implement and meet the task demands of the HF4Y program model. This will help

identify where more time, training, and resources may need to be allocated to achieve success.

Does your organization have a track record of working with vulnerable youth?			
Do your organization's policies and procedures support the HF4Y program model (e.g., providing on-call support, smaller caseloads, the ability to sign master leases for youth under the age of eighteen, etc.)?			
Does your organization have the knowledge, staff, and skills to positively support specific subpopulations such as Indigenous, LGBTQ2S, and racialized/minority youth?			
Does your organization have the backing from the Board of Directors and internal capacity to support staff in implementing HF4Y?			
Is there multi-year funding in place?			
Will that funding allow for the smaller case management caseloads required to deliver the program?			
Does the organization have capacity to properly supervise and support the program staff?			

Is the organization able to invest in HF4Y training for program managers and staff?

*Context and Collaboration for HF4Y*

Local buy-in is required to effectively implement HF4Y, which includes building on the work and successes of community partners.
